- 4 BUSINESS ARISING FROM PREVIOUS MINUTES:

1 Establishment of a Permanent Office

In discussions with Mark McGillvray representing the Rec Centre, it was determined the area to the right of the foyer would be the preferred location for the office.

2 Keith provided information on modifications made to accommodate the new office.

Changes to mailing address were being made with all contacts as the mail had been forwarded to the 2155 Kingston Rd location.

Discussion on decision of Laine Brehaut to resign position of CAO, Offer by Keith Boire to resign from councilor and offer to take on the role of CAO.

2 Municipal Priorities for Paving and other Roadwork

Alan drafted and sent a letter to the Province indicating the priorities of council which were discussed at the May meeting.

- Fibre Opt Project Press Release is finally on our web page dated July 8th 2022.
- Official Plan A timeline to present a draft Plan, a timeline to amend Bylaws Special consideration for current Excavation Pit Bylaws, Private Road restrictions and Shared Driveways were discussed.
- 5 COMMUNITY PLANNING: The following items were discussed.
 - 1. Mirko's Updated report on status of Development and Subdivision Applications. Audio quality was very poor.
 - 2. Resolution to grant Special Development Permit Excavation Pit was passed.
 - Status of Elmwood Excavation Pit application.

Michael had contacted Island Coastal three times and they never got back to him. This needs to be treated as a new pit and whatever restrictions we want to see for the Municipality needs to be considered when reviewing the bylaws.

4. Younker Subdivision Application

David Younker met with me yesterday to discuss plans for a subdivision off the Quinn Road. His property is within the SPA. There has been one lot taken off the parcel in 2011. I let him know the max lots available are 5, so only 4 more allowed off that parcel.

Also let him know about recent changes to the Act affecting the SPA.

 Call from Province (Brad Wallace) re Road development -Westwood and Kingswood

Brad Wallace was informed all communications related to Westwood subdivision should be directed to the Province.

Any road work related to Kingswood would have to comply with both Kingstons bylaws and Provincial Road regulations. Potential developer Paul and Trish Neima have not yet decided whether or not they will pursue further development.

6 FINANCE REPORT:

- All active banking has been changed to the Provincial Credit Union. Our Royal Bank account will remain open until the end of February as all financial records should be a one institution prior to years end.
- 2. Current financial bank balances and expenditures were shared with Council.

7 ADMINISTRATORS REPORT
